



## LIVELIHOOD (Tulong-Pangkabuhayan)

*Throughout the countryside and among the urban poor, unemployment remains a major problem even as the government has made headways in attracting investors to the Philippines and maintaining the stability of the national economy.*

*The lack of competitive formal education among many Filipinos, the limited access to capital, and the limited capacity of existing business investments to absorb the growing workforce of the country has resulted in varying degrees of unemployment among Filipinos.*

*The Livelihood (Tulong-Pangkabuhayan) Program seeks to help improve socio-economic conditions in the countryside by encouraging the establishment of small-scale or alternative income-generating activities, and fostering the concept of self-help among members of the community.*

### Help establish livelihood projects in your own locality.

Your.....

- **US\$ 150** can start a “tubong-lugaw” individual livelihood project like banana-Q, kakanin, lutong-bahay, barbecue, pansit, or lugaw vending.
- **US\$ 500** can be used as seed capital for a sari-sari store.
- **US\$ 1,000 to 2,000** can provide capital for a small-scale cottage industry project.

There is no limit to the financial assistance a donor may grant. Donations may be directed to local communities and barangays, non-government organizations and cooperatives. Donors may also provide support to existing community livelihood program initiatives of local government sectors.
